We are pleased to present the report on the Postal ballot conducted by **Shreyas Shipping And Logistics Limited ("The Company")** seeking consent of its Members for the Resolutions as contained in "the Notice" of the Postal Ballot dated **02nd June 2023.**

- In terms of provisions of Section 110 of the Companies Act, 2013 ("the Act") read with Companies (Management and Administration) Rules, 2014, I, Vicky M. Kundaliya, Practicing Company Secretary, Proprietor of M/s. V. M. Kundaliya & Associates, Mumbai, have been appointed as the Scrutinizer by the Board of Directors of the Company on 24th May 2023 to scrutinize the voting process conducted through remote e-voting and submit a report thereon.
- 2. In terms of Sections 110 read with 108 of the Companies Act, 2013, and all other applicable provisions, if any, of the Act read with Rules 20 & 22 of the Companies (Management and Administration) Rules, 2014 and in accordance with the relevant circulars issued by the Ministry of Corporate Affairs (MCA) from time to time, Members' approval was sought for the Resolution as contained in the Notice of Postal Ballot through e-voting only.
- 3. My responsibility as the Scrutinizer of the voting process, is restricted to scrutinize the e-voting process, in a fair and transparent manner and to prepare Scrutinizer's Report of the votes cast in favour and against the resolution stated in the Postal Ballot Notice, based on the reports generated from the E-voting provided by Link Intime India Private Limited (LINK INTIME), the service provider.

The Company had availed the e-voting facility offered by LINK INTIME to provide e-voting facility.

4. Notice of the Postal Ballot

- 4.1 The Company has informed, that on the basis of the Register of Members and the List of Beneficial Owners made available by the Depositories viz., National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL), as on 01st June 2023 ("the cut-off date"), the Company has completed sending of Postal Ballot Notice through email to 17290 no. of Members who had registered their email-ids with the Company/Depositories/Registrar and Share Transfer Agents (RTA) on 01st June 2023.
- 4.2 Pursuant to Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 and the relevant MCA Circulars, the Notice of Postal ballot and remote E-Voting information was published on 03rd June 2023 in Financial Express (English language) and Loksatta (Marathi language), post dispatch of Notice of Postal ballot to the shareholders.





In terms of aforesaid Notice, Members were required to convey their assent or dissent, only through remote e-voting system, on e-voting platform provided by Link Intime from Sunday, 04th June 2023 (10.00 A.M. I S T) to Monday, 03rd July 2023 (5.00 PM I S T). The remote e-voting module was disabled by LINK INTIME thereafter.
